**ELECTIONS SHALL BE HELD ON FRIDAY, MAY 1, 2020 AT THE

from 7:30 a.m. to 4:30 p.m.**

To be eligible for Office, a member must be in good standing in the P.C.T.E.A. for one (1) year immediately preceding the election. A member must have paid union dues for one (1) year in the P.C.T.E.A. No retired members can run for Office. When a leave of absence without pay is granted by the Board of Education pursuant to the contract, a member shall be ineligible to run for office if dues are not paid during this time and the leave exceeds two (2) calendar months. Only one such leave shall be granted within a two (2) year period. Voting is for P.C.T.E.A. members only.

Any employee, who is a dues paying member, which will be certified by the latest check-off roster nearest the May 1, 2020 date, is eligible to vote.

Any person who desires to be a candidate does not have to appear in person, but must have an eligible voter place his/her name in nomination.

All declinations will be accepted, in writing, no later than March 27, 2020 and must be directed to the Election Chairperson at 807-C City Hall by fax at 851-3916, or by email at cturton@buffaloschools.org.
